## 1. Agency and Contracting Activity.

The Department of Homeland Security (DHS), U.S. Immigration and Customs Enforcement (ICE), Office of Acquisition Management (OAQ), prepared this justification for an exception to fair opportunity on behalf of ICE/Homeland Security Investigations (HSI)/Worksite Enforcement Unit (WSEU).

## 2. Nature and/or description of the item/service being procured and anticipated cost:

- (a) Type of action: Labor Hour Task Order 70CMSD18FR0000069 modification
- (b) Amount the current J&A is justifying: \$6,567,928.51 (with FAR 52.217-8 included) 46% increase to total contract value.
- (c) Brief Description: OAQ intends to modify an existing order, on a sole source basis for I-9 Support Services. The vendor listed below is currently performing the work under this contract and has in depth knowledge of the unique mission of the WSEU which is required to fill the position with the appropriate personnel.

### 3. Description of Supplies/Services.

WSEU requires additional I-9 Support Services. Twenty-seven (27) additional Junior Compliance Officers (JCOs) to audit employers' I-9 records to detect hiring of illegal immigrants. Findings from data collected and analyzed is used for investigative purposes and possible prosecutions. These auditing support services assist HSI's worksite enforcement strategy of removing the magnet of illegal employment by targeting egregious employer violations and abuses in both critical infrastructure protection (CIP) business sectors and non-CIP business sectors. The WSEU also seeks to identify cases of identity theft and other criminal violations committed by those who knowingly and willfully violate our nation's immigration laws, to include employers who are engaged in wide-spread violations of the laws designed to ensure the employment eligibility of our nation's workforce. The cost to provide 27 additional JCOs is estimated at \$6,567,928.51 (including FAR 52.217-8).

<sup>\*17-</sup>month base period is due to a POP extension this modification will include due to Government delay of 120 calendar days for PSU clearance process and 33 day Government Shutdown, for a total of 153 day POP extension on the base period of performance. Although the Government is extending the period of performance on the base period; any labor hours worked beyond the 12-month period of the base period (FY18 funding), will be paid for with FY19 funding. In order to ensure compliance with fiscal law, the contracting officer will include an additional CLIN in this modification that will separate FY19 funding and all labor hours expended as of September 2, 2019 will be paid for with FY19 funding, which will be added with this modification.

### 4. Statutory Exception and rationale for its use:

Only one awardee is capable of providing the supplies or services required at the level of quality required because the supplies or services ordered are unique or highly specialized. ### Rationale:

The intial order was competed among OASIS Small Business (SB) Pool 2 vendors. All contractors proposed fixed labor rates for a labor category entitled. "Junior Compliance Officer." OAQ made a single award to staff contractor employees at all existing HSI Special Agent in Charge (SAC) offices to assist with the ongoing audits of employer records. After award, four new HSI SAC offices were opened, including: Charlotte/Charleston. Kansas City, Las Vegas, and Nashville/Louisville. HSI could not reasonably forecast when the additional SAC offices would be open or be prepared to house and support additional contractors working on-site prior to award. Had these offices been in existance at time of award, OAQ would have included them in the initial award.

The new work is a logical follow on to the original order in that the contractor already has junior compliance officers in the current locations and is successfully performing the work; training classes for the contractor have already taken place and the contractor is abreast of the workload and the skills needed to successfully complete it. The benefit and value the Government will receive by modifying the original order is significant. The recompete costs and procurement lead times would render HSI unable to accomplish its mission during a critical time where the United States is experiencing an immigration crisis. The original order took 3.5 months to award. This work was already delayed during the Jan 2019 shutdown; therefore another 3.5 month delay would be unacceptable

The workload at the original locations has also increased, based on the enforcement initiatives and the influx of illegal immigration, the required number of I-9 audits has grown exponentially to support investigation requirements. This additional work is within scope due to two facts (1) that it was known at time of award that the I-9 investigations were increasing, and (2) the Government awarded a contract to staff all HSI SAC offices, not merely some of them. The need to provide additional contractors to support the workload of the original HSI SAC office locations was due to the case backlog resulting from previous surges associasted with the I-9 investigations. Specifically, the original HSI SAC offices that were identified as having an additional need were those offices that had a total of 2.174 cases backlogged, see below table 2 below for details. Due to the overall operational increase of audit requirement, Management for the HQ Work Site Enforcement (WSE) Center determined there is a work related need for approximately 5 additional contractors, for a total of 10.100 labor hours. This need increased to 14 contractors for a total of 28,280 labor hours based on the need to assist the HSI field offices for the upcoming audit surge operations.

To provide a bit of background information the prior fiscal year (FY) Form 1-9 inspection requirements increased by 78% from 1,334 in FY 2017 to 5,981 in FY 2018. As a result of the enforcement initiatives the audits for FY 2019 will continue to increase by 5% for a total of 6,300 inspections.

The increased workload is identical to that being currently performed, however, additional JCOs are required at both existing and the new locations. The total JCO enhancement is 27 JCOs. Original award was for 63 contractor employees, bringing the current total to 90 contractor employees. HSI has hosted JCO training for Hamilton Enterprises employees and has currently trained 42 contractor JCOs. This additional work is a logical follow on to the current order as Hamilton employees are currently providing this specialized work, have been trained on the Government procedures for processing data that will be utilized during investigations and possible prosecutions. Awarding this follow-on work to a new vendor would result in increased and duplicative training costs clearance costs and time, and administrative costs which are not expected to be offset through savings resulting from recompeting this new work.

If future needs occur for same or similar services, a new contract will be competitively awarded.
